According to Decision No.10 / 2017 of the UAE Cabinet Decision, the United Arab Emirates (UAE) enforces the RoHS (Restriction of Hazardous Substances) Certification from 1st January 2018, subjecting all regulated products to a mandatory Certificate of Conformity under RoHS regulation.

SGS is the approved Certification Body for RoHS certification under ESMA

### **Emirates Conformity Assessment Scheme (ECAS) Process**



#### Option 1:

- Declaration of Compliance including only critical components
- Full RoHS test reports of the complete product
- Valid UAE Trade license
- Verify compliance to requirements
- Certificate issued for 1 year

#### Option 2:

- Declaration of Compliance including only critical components
- Risk assessment documents based on IEC 63000/ EN 50581 and IEC 62476
- Verify test reports for 3 critical components
- Verify compliance to requirements
- Valid UAE Trade license
- Certificate issued for 1 year

## **Emirates Quality Mark (EQM) process**



#### Option 3:

- Declaration of Compliance
- Risk Assessment documents based on IEC 63000/EN 50581 and IEC 62476
- Technical audit & verification through onsite visit
- Valid UAE Trade License
- Verifies compliance to requirements & issue certificate & License to use EQM
- Certificate issued for 3 years

FAQ-Frequently Asked Questions

- Q: What are the products covered under UAE RoHS program?
- **A:** All EEE- Electrical & Electronics equipment including large & small household appliances, Household Consumer equipment, Lighting equipment, IT and Telecommunication equipment etc.
- Q: Is this certificate different from the current ESMA ECAS/EQM certificate?
- **A:** Yes, this certificate specifically covers RoHS scope which will be separate certificate apart from current ECAS/ EQM certification and can be directly applied with SGS Gulf Ltd along with normal ECAS/EQM applications.
