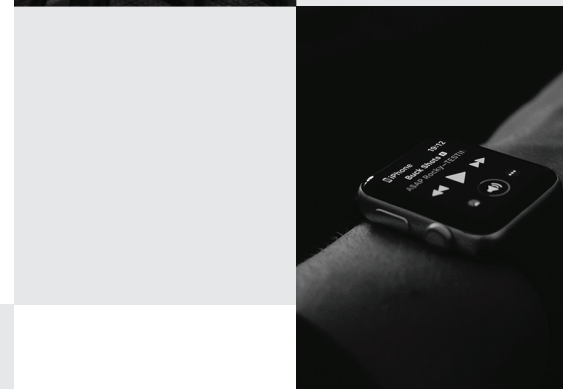
The Veco Group – About us
